## Cancellation and Refund Policy Agreement

**For Taste the Adventure participants and their parent or legal guardian (“parent”)**



You will receive an email acknowledgement regarding receipt of your registration/deposit and a phone or skype appointment to discuss your arrival to and departure from Taste the Adventure. If you have not received this within 72 hours of registration, please call us at 919-942-6550. Before your session(s) we will send you a packing list, and nuts and bolts information you need to know. All participants are expected to sign and comply with all Taste the Adventure Terms and Conditions as outlined on that form.

**Disclosure:** parents/guardians are expected to ensure that full disclosure is made regarding any physical or mental condition that has any potential to affect the participant’s ability to participate on the trips. Withholding information is considered a breach of contract. This obligation continues on an ongoing basis even after registration is complete and all forms are submitted.

**Cancellation and Refund Policy:** should you decide to cancel your Teen’s enrollment in the program before March 1, all but \$250 of your \$2375 deposit will be returned to you. Cancellation for whatever reason after March 1 will forfeit your entire deposit. We reserve the right to dismiss any participant for disruptive, unbecoming, immoral or disobedient behavior at our sole discretion, without refund, at the parents/guardians expense. Dismissed participants must be provided either a guardian for pickup or a ticket home within 12-24 hours of dismissal. Participants understand and agree that if they are present when others commit these sorts of offenses they are culpable as well and expected to notify a trip leader. Taste the Adventure reserves the right to cancel or change the program itinerary, location, dates or duration for any reason at any time. We are not responsible for costs incurred by families in preparing for a program that is altered or canceled. We are not responsible for airfare purchased for a trip that is altered or canceled. Balance is due by May 1 of the enrolled program year.

**Applicable law and venue:** I have accurately and fully completed this registration form and will do so for all future materials, and agree to the terms and conditions outlined above. I will promptly review and complete all materials when forwarded to me. I give permission for my Teen to participate in Taste the Adventure Program activities whether conducted by Taste the Adventure or a subcontractor and fully release Taste the Adventure and its contractors from any and all liability associated with program participation.

In the unlikely event of a dispute, I agree that this registration and all other aspects of my and my child’s relationship with Taste the Adventure will be governed by North Carolina state law, specifically the rules of Orange County, North Carolina. Venue for dispute resolution will be Orange County, North Carolina.

**Any additional forms:** are to be completed by parents and physician as well as packing lists, travel tips, travel insurance information, legal/medical forms and other important information will be sent via email, but can be mailed to participants upon request.

We make every effort to reach a parent /guardian in the event care is sought or deemed advisable and will attempt to make contact again regarding any medications recommended or prescribed. However, parents are expected to make full disclosure of any medications a child cannot take. If we cannot reach a parent, or in case of emergencies, we will use our discretion.

**Photos and videos:** Taste the Adventure reserves the right to use any photos, videos or testimonials from its trips in any manner it desires.

**Lost, stolen or damaged property and lost luggage:** Taste the Adventure and its staff are not responsible for the loss and/or recovery of any lost, stolen or damaged belongings. In the event of lost luggage we will help as much as we can, but the responsibility for recovering lost luggage, insuring that the participant has enough clothes and supplies to continue and the lost luggage returned while on the trip is up to the parents /guardians.

**Late Registrations:** Students are welcome to sign up for all trips up until the date of departure provided there is space on the trip. For each sign up after the April 20 registration deadline there will be an additional \$250 late fee charge.

**Flights and Transportation:** Parents should verify the availability of flights prior to booking. Participants are have the option to fly independently (unaccompanied minor fees may apply ) We assume no liability for these flights so it is crucial that parents check flight details carefully.

We assume no responsibility for any delay, cancellation or strike of flights, public transportation such as buses, trains, ferries, metros and the like, and reserve the right to organize alternate transport as necessary. Any additional costs incurred as a result of these delays or cancellations are your responsibility and expense.
